- 3. Normally members have the right to appoint a proxy of their choice, who need not be a member, to exercise all or any of their rights, to attend, speak and vote at the AGM. In light of the decision to not having a public meeting the Chairman of the AGM will exercise your vote as indicated on this form. This is your opportunity to exercise your right to vote.

Summary Notes for Completion of the Proxy Form

- 1. Please write your name in the field shaded yellow.
- The Rules of EBCLT state that one third (or the number nearest one third) of the Trustees must retire at each AGM. A retiring Trustee is eligible for re-election. The three retiring Trustees are all standing for re-election.

The Rules of EBCLT state that the maximum number of Trustees is 9. Before the AGM 7 Trustees were in place. The request for nominations did not result in any member coming forward for election. With the compulsory retirements a total of up to 3 trustees can be elected at the AGM. Without any additional nominations received, only the three retiring trustees are standing for election.

- 3. If you do not indicate a choice by either voting "for", "against" or "abstain, the Chair has full discretion to cast the votes for you. Voting can only be effected via proxy.
- 4. The proxy form must be signed and dated to be valid.
- 5. Except for the voting, this year the AGM will be conducted virtually. Please indicate on the proxy form whether you would like to attend via the electronic platform.
